

**NOTIFICATION FOR ON DEMAND EXAMINATION -23/2020**

For the reason that due to Covid 19, the public examination that was to be conducted in March/April 2020 could not be held. A notification dated 10.07.2020 in this regard was issued to take care of the interest of the learners. Accordingly, based on the alternative assessment scheme of result computation, result of the learners registered for public exam was computed and declared on 5<sup>th</sup> August 2020. It is further informed that the said notification dated 10.7.2020 was confirmed by the Hon'ble Supreme Court in a series of cases which found that the computation of marks pursuant to the representation made by the learners were correct in terms of the said notification.


Now, pursuant to Circular No. No. 9-71/2020/NIOS/Eval/ODE dated 31.08.2020, it is brought to the notice of learners who are interested in or intend to improve their scores are given option to take the On Demand Examination to be held from 05<sup>th</sup> October 2020 for theory components only. Those learners interested in or intend to improve their scores can book the seat for On Demand Examination through their dashboard on the student portal of NIOS (sdmis.nios.ac.in). The On Demand Examination link will be open for seat booking purpose w.e.f. 25.9.2020. It is further to bring to your notice that those learners who were registered to appear in public examination for improvement or Stream-2 cases declared as Not computable cases in March/April 2020 Public Examination are exempted from paying the examination fee for booking seat in the said On Demand Examination. However, all others will have to pay the requisite fee online through their dashboard. No enquiries in this regard will be entertained.

Those who are intending to take the On Demand Examination from 05<sup>th</sup> October 2020 onwards, the marks obtained therein by the registered learners will be treated as final for all purposes. Their cases cannot be reopened at any cost. It is further clarified that notification dated 10.7.2020 will not apply for On Demand Examinations for working out or ascertaining their marks and thus no dispute shall be entertained in this regard as the On Demand Examination will be held at the Examination Centre (Regional Centre) selected by the learner while booking the seat for On Demand Examination.
